Rename Koriawas medical college or face poll losses, BJP MLA warns party

MAHENDRAGARH, IULY 29

Extending support to the ongoing protest in Koriawas village here, BJP MLA from Narnaul and former minister Om Prakash Yadav has warned his party and its leaders — including himself — of facing losses in the next elections if the demand to rename Maharishi Chyawan Government Medical College after freedom fighter Rao Tula Ram is not fulfilled.

"The demand is completely justified. Freedom fighter Rao Tula Ram led a valiant struggle during the 1857 freedom movement, where over 5,000 people sacrificed their lives the highest number across the country. The battlefield is just 4 km from the medical college, and the panchayats of over 150 villages have extended their support to this demand," said Yadav while speaking to *The* Tribune on Tuesday.

Notably, the BJP secured three out of four Assembly seats in Mahendragarh district during the 2024 elections. Arti Singh Rao, the MLA from Ateli, currently serves as the Health Minister in the state government

When asked why the issue wasn't raised earlier, Yadav, a close aide of Union Minister Rao Inderjit Singh, said that he and other MLAs had proposed the name of Rao Tula Ram for the college

This infuriated the local people, leading to damage of the signage of the college in May as a mark of protest," he said.

AMBALA, JULY 29 Nearly a month after the Haryana State Pollution Control Board imposed an environmental compensation on the Municipal Corporation Ambala for irregularities found at the solid waste management plant in Patvi village, the BJP MC Mayor has also

Nominated member Sandeep Sachdeva said: "It is a matter of investigation that a huge quantity of garbage remains along the roads, if 220 tonnes of waste is being dumped at the plant."

HISVP MULTI-CRORE SCAM

Revealing the modus operandi of ex-MLA Ramniwas Surjakhera and his associates in defrauding Haryana Shehri Vikas Pradhikaran (HSVP), the Enforcement Directorate has told a special court in Panchkula that he, while working as an accountant before joining politics, fraudulently opened HSVP accounts in Punjab National Bank, Manimajra, to siphon off close to "Rs 100 crore."

HSVP had got registered an FIR at Sector 7 police station in Panchkula in March 2023, claiming that from 2015-19, multicrore debit transactions were made in favour of certain parties without any reason. An internal inquiry of HSVP found that the Manimajra bank's transactions were not reflected in the records of its cash branch or IT wing, indicating that the accounts were operated fraudulently.

The ED registered a case in October 2023. It found that from 2015 to 2019, the period during which the scam took place. Ramniwas had served as accounts assistant till 2017, and Sunil Kumar Bansal served as senior accounts officer till 2019. A branch head of IDBI, Lohgarh (Yamunanagar), had recorded his statement before ED that Ramniwas and Bansal

came to his residence to facili-

tate the opening of several bank

accounts, on the explicit condition that large sums of cash would be withdrawn from these accounts held in the names of various individuals. He said they would make phone calls to him before credits were made to these accounts from HSVP (erstwhile HUDA) accounts, and again after the credits, to confirm that the amounts were successfully deposited. Following this, both accused would direct him over phone calls to arrange for cash withdrawals from these accounts.

During a hearing before the Special Court under the Prevention of Money Laundering Act, Panchkula, ED, represented by counsels HPS Verma and Zoheb Hossain, submitted that during the relevant period (2015-19), "more than Rs 100 crore was withdrawn in cash from this branch."

ED further told the court that several beneficiaries who had

fraudulently received funds admitted that, while visiting the HSVP office to claim compensation for land acquired. they came into contact with Ramniwas. He offered to assist them in securing their compensation and, in return, asked them to provide details of bank accounts held in their names or those of their family members.

"He (Ramniwas) informed them that funds from HSVP, different from their actual compensation amount, would be credited to these accounts and that the funds would either be returned in cash or transferred further as instructed by him,"

These people told ED that the amounts were withdrawn and were handed over to Ramniwas and Bansal. Investigation into the money trail revealed that ex-MLA Ramniwas not only received proceeds of crime in his bank accounts but also in the accounts of his family members, including his wife, Manjit. ED further claimed that a Toyota Fortuner was purchased using the money and was subsequently transferred into ex-MLA's name without any legitconsideration

Ramniwas was arrested on June 9 in the case. Rejecting his bail application, the court said: "In the face of very serious allegations of money laundering, it is not possible, at this stage, to grant concession of bail to the

CHANDIGARH, JULY29 More than 15 years after 254 families fled Mirchpur village in Hisar district following castebased violence, the Punjab and Haryana High Court has dismissed a plea seeking enhanced compensation of Rs 1 crore in case of death and Rs 25 lakh for injuries.

"The court is constrained to observe that the entire exercise appears to have become a commercial enterprise," the Bench of Chief Justice Sheel Nagu and Justice Nidhi Gupta asserted, while dismissing a petition seeking review of an earlier order. The Bench noted that the

State of Haryana had already allotted 258 plots to 254 displaced families and that more than 200 families had been provided plots measuring 85 square yards each. "It has been admitted by the review petitioners... that in respect of the said 254 displaced families, 258 plots have been allotted," the court noted. As for the allegation that 15 victims remained without allotment, the Bench Says exercise has become 'commercial enterprise'

found the claim to be "incorrect". Referring to a status report filed by the Special Secretary, Home Department, it said only 33 families had migrated from Mirchpur following the April 2010 violence and had subsequently

returned to the village without reporting any threat or incident

"In this situation, it is not clear as to why petitioners insist on continuing to reside at private property by the name of Tanwar Farmhouse and are

insisting for their rehabilitation outside their native village," the Bench remarked. It observed that the petitioners'

continued refusal to return lent credence to the State's argument that they preferred to live near Hisar city due to better

earning opportunities. "Needless to say, the same cannot constitute a ground for shifting and for rehabilitating them," the Bench said.

The court also took note of the state's claim that extensive monetary relief had already been provided. In one such case, Rs 15 lakh compensation had been granted to Kamla Devi for the death of her husband Tara Chand and three plots awarded to her three sons, who were also given ex-gratia permanent government jobs, government accommodation and even a gunman.

The Bench further recorded that 26 others had been provided gunmen and that 77 CRPF personnel were deployed for protection of victims and witnesses. Approximately Rs 20 crore was spent on the security arrangements.

Dismissing the petition, the court observed that no ground was made out for review of the January 9, 2024, order, but granted liberty to the petitioners to approach the competent authority in case any grievance still survived.

No tehsildar appointed for month, land registry work stuck in Sirsa

SIRSA, JULY 29

Land registration work at the e-Disha Centre in Sirsa has slowed down badly. People who got tokens 3-4 days ago are still standing in long queues, waiting for their turn, but most of them are unable to complete their land registry. The main reason is that a

new tehsildar has not been appointed, even though the previous tehsildar was suspended a month ago over an alleged bribery incident.

The previous tehsildar, Bhuvnesh Kumar, was suspended immediately by the government after MLA Gokul Setia shared a CCTV video on social media, where Bhuvnesh was allegedly seen talking about bribe-related matters. Since his suspension, the government gave the responsibility of land registry work to the Naib Tehsil-



dar, District Revenue Officer (DRO), and the Sub-Divisional Magistrate (SDM). Kamal Singla, a resident

who came to register a plot,

said he arrived on Friday, but the Naib Tehsildar was on leave. He took a token for Monday, expecting his turn at 10 am, but even then, his work was not done. He claimed the Naib Tehsildar only marked registries after 2 pm, and since e-Disha closes by 5 pm, many people went back without getting their work done. He also

said although three officers had been assigned for registries, only the Naib Tehsildar is actually doing the work, while the other two are not processing registries even though tokens were issued under their names.

Earlier around 150 registries were done each day. Now, the number has fallen to less than half. Another resident, Rajender Kumar, said he gave a written complaint to the SDM, asking that the registry hours be extended so that at least the

He said the SDM took the letter but left immediately in his car without giving any response. Naib Tehsildar Subhash Chandra admitted that his workload had become too much, but he was trying his best to manage. He explained that the staff is new and untrained, which is causing further delays. He added that he also has the charge of Nathusari Chopta, and on the day in question, he had to attend Dabwali court all day, so the Sirsa work was delayed. He also said the other two offi-

DRO Sanjay Chaudhary said although he was given additional charge of Tehsildar, he had informed the government in writing that he would not take the charge because it was a lower post compared to his current position.
